

Privacy Policy

We take your privacy rights very seriously.

We occasionally will provide you the option of registering your email via our apps and/or websites so that we may send email updates to those who wish to subscribe. We consider this as consent from you to store your email address and we will store your email address and name securely in a database. We will store this until you either ask us to remove it, or until we decide that we do not want to continue to send emails to our subscribers. You will be able to unsubscribe from any email newsletters by clicking 'Unsubscribe' on the newsletter.

Really Quite Something Ltd. build apps and websites as a data processor, and as a result we sometimes store data on behalf of our clients. Should you ever want us to entirely delete your data, would like to see what we have stored, or would like to raise a complaint then you can contact us through our website www.reallyquite.com.

Please note that data about your usage of any app we publish is also recorded by Apple (for iOS) and Google (for Android). They keep analytics on the usage of the app and any financial data related to app purchases and in-app purchases.

If you have selected to receive Push Notifications via one of our apps, then we will store your device ID so that you can receive these from us also.

Your privacy is critically important to us. Really Quite Something Ltd. have a few fundamental principles:

- We don't ask you for personal information unless we truly need it. (We can't stand services that ask you for things like your gender or income level for no apparent reason.)
- We don't share your personal information with anyone except to comply with the law, develop our products, or protect our rights.
- We don't store personal information on our servers unless required for the on-going operation of one of our services.
- In our social networking and mobile application products, we aim to make it as simple as possible for you to control what's visible to the public, seen by search engines, kept private, and permanently deleted.

Below is our privacy policy which incorporates these goals:

Really Quite Something Ltd. ("Really Quite") operates several websites including tunepropeller (collectively, the "Websites"), as well as a number of mobile applications on behalf of our customers (collectively, the "Applications"). It is Really Quite Something Ltd.'s policy to respect your privacy regarding any information we may collect while operating our Websites and Applications.

website visitors and application users

Really Quite Something Ltd. collects non-personally-identifying information of the sort that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request. Really Quite Something Ltd.' purpose in collecting non-personally identifying information is to better understand how Really Quite Something Ltd.' visitors use its Websites and Applications. From time to time, Really Quite Something Ltd. may release non-personally-identifying information in the aggregate, e.g., by publishing a report on trends in the usage of its Websites or Applications.

Really Quite Something Ltd. also collects potentially personally-identifying information like Internet Protocol (IP) addresses. Really Quite Something Ltd. does not use such information to identify its visitors, however, and does not disclose such information, other than under the same circumstances that it uses and discloses personally-identifying information, as described below.

gathering of personally-identifying information

Certain visitors to Really Quite Something Ltd.'s Websites and users of Really Quite Something Ltd.'s Applications choose to interact with Really Quite Something Ltd. in ways that require Really Quite Something Ltd. to gather personally-identifying information. The amount and type of information that Really

Quite Something Ltd. gathers depends on the nature of the interaction. For example, we ask visitors who sign up for a social network or application at tunepropeller to provide a username and email address. Those who engage in transactions with Really Quite Something Ltd. – are asked to provide additional information, including as necessary the personal and financial information required to process those transactions. In each case, Really Quite Something Ltd. collects such information only insofar as is necessary or appropriate to fulfill the purpose of the visitor's interaction with Really Quite Something Ltd.. Really Quite Something Ltd. does not disclose personally-identifying information other than as described below. And visitors can always refuse to supply personally-identifying information, with the caveat that it may prevent them from engaging in certain Website-related and Application-related activities.

aggregated statistics

Really Quite Something Ltd. may collect statistics about the behavior of visitors to its Websites and users of its Applications. For instance, Really Quite Something Ltd. may monitor the most popular social networks or applications on the tunepropeller site. Really Quite Something Ltd. may display this information publicly or provide it to others. However, Really Quite Something Ltd. does not disclose personally-identifying information other than as described below.

protection of certain personally-identifying information

Really Quite Something Ltd. discloses potentially personally-identifying and personally-identifying information only to those of its employees, contractors and affiliated organizations that (i) need to know that information in order to process it on Really Quite Something Ltd.'s behalf or to provide services available at Really Quite Something Ltd.'s Websites and Applications, and (ii) that have agreed not to disclose it to others. Some of those employees, contractors and affiliated organizations may be located outside of your home country; by using Really Quite Something Ltd.'s Websites and Applications, you consent to the transfer of such information to them. Really Quite Something Ltd. will not rent or sell potentially personally-identifying and personally-identifying information to anyone. Other than to its employees, contractors and affiliated organizations, as described above, Really Quite Something Ltd. discloses potentially personally-identifying and personally-identifying information only when required to do so by law, or when Really Quite Something Ltd. believes in good faith that disclosure is reasonably necessary to protect the property or rights of Really Quite Something Ltd., third parties or the public at large. If you are a registered user of an Really Quite Something Ltd. Websites or Applications and have supplied your email address, Really Quite Something Ltd. may occasionally send you an email to tell you about new features, solicit your feedback, or just keep you up to date with what's going on with Really Quite Something Ltd. and our products. We primarily

use our various product blogs to communicate this type of information, so we expect to keep this type of email to a minimum. If you send us a request (for example via a support email or via one of our feedback mechanisms), we reserve the right to publish it in order to help us clarify or respond to your request or to help us support other users. Really Quite Something Ltd. takes all measures reasonably necessary to protect against the unauthorized access, use, alteration or destruction of potentially personally-identifying and personally-identifying information.

cookies

A cookie is a string of information that a website stores on a visitor's computer, and that the visitor's browser provides to the website each time the visitor returns. Really Quite Something Ltd. uses cookies to help Really Quite Something Ltd. identify and track visitors, their usage of the Really Quite Something Ltd. Websites, and their website access preferences. Really Quite Something Ltd. visitors who do not wish to have cookies placed on their computers should set their browsers to refuse cookies before using Really Quite Something Ltd.'s Websites, with the drawback that certain features of Really Quite Something Ltd.'s Websites may not function properly without the aid of cookies.

ads

Ads appearing on any of our Websites or Applications may be delivered to users by advertising partners, who may set cookies. These cookies allow the ad server to recognize your computer each time they send you an online advertisement to compile information about you or others who use your computer. This information allows ad networks to, among other things, deliver targeted advertisements that they believe will be of most interest to you. This Privacy Policy covers the use of cookies by Really Quite Something Ltd. and does not cover the use of cookies by any advertisers.

privacy policy changes

Although most changes are likely to be minor, Really Quite Something Ltd. may change its Privacy Policy from time to time, and in Really Quite Something Ltd.' sole discretion. Really Quite Something Ltd. encourages visitors to frequently check this page for any changes to its Privacy Policy. If you have a tunepropeller account, you should also check your social network dashboard for alerts to these changes. Your continued use of this site after any change in this Privacy Policy will constitute your acceptance of such change.
